



DIFFA'S DINING BY DESIGN 2008 *DIFFA HISTORY AND GRANT MAKING*

DIFFA: Design Industries Foundation Fighting AIDS is one of the oldest and largest funders of HIV/AIDS service and education programs in the U.S. Since its founding in 1984, DIFFA has mobilized the immense resources of the design communities to provide in excess of \$31 million to over 500 AIDS organizations nationwide to service providers offering direct care, education, prevention programs, advocacy and public policy.

Drawing on the contributions of world-renowned creative and corporate leaders, DIFFA's fundraising activities are among the most celebrated in AIDS philanthropy. Through special events and "passive royalty" arrangements, DIFFA raises money for the battle against AIDS like no other organization can. This unique position has enabled DIFFA to cement its reputation for innovation by rallying diverse communities to a common purpose.

DIFFA/Chicago is one of 15 chapters nationwide of DIFFA: Design Industries Foundation Fighting AIDS established in 1984. These chapters have distributed over \$31 million to community-based organizations providing direct service, preventive education and outreach to people who are HIV positive, living with AIDS or at-risk of infection. In addition DIFFA granting helps feed, provide healthcare, defends rights and provide care for people at the end of life.

DIFFA/Chicago provides **Excellence in Care Awards** to Chicago-area service providers. A team, consisting of a professional in that field and DIFFA/Chicago Board Members, reviews each agency applying for funding. Review of proposals, are followed by site visits and interviews with the organizations' staff. We fund in the categories of advocacy and education, health and clinical services, meals and nutrition, housing, and support and counseling. The agencies shown to provide the best care receive an unrestricted grant.

In 1991, the DIFFA/Chicago Fellowship was established at Northwestern Memorial Hospital to fund HIV/AIDS research, patient care and education. Past DIFFA/Chicago fellows have gone on to enhance the healthcare for countless individuals throughout the globe. Some are currently working in Patras Greece, Singapore, Dublin Ireland, St. Louis, Austin, Oak Lawn and Chicago.

The DIFFA/Chicago granting process selects agencies providing the best care possible in Chicago and the ability to put dollars where they have the most impact to help the men, women and children living with HIV/AIDS.

DIFFA's grant making tradition has been to support start up or emerging programs and ideas that reflect a unique or innovative approach to a problem. DIFFA also seeks proposals that include appropriate and strategic collaboration among agencies. We continue to seek requests where public support and other philanthropy (including an organization's own fund raising capacity) is not otherwise available and where DIFFA funds can be appropriately positioned to expand and diversify the funding efforts of an organization.
